What MOAR? - Educate Legislators Now

- Please know that House budget proposal comes out generally in April.
- The Senate Budget usually comes out in May.
- The House and Senate Budget must be reviewed and consolidated as one.
- Differences resolved in a Conference Committee and passed by June 30th.
- The Governor must review, sign, or veto (reject) by line item;
- The State Legislature can decide to reject the vetoes
- The House must decide to override (reject) vetoes first, then the Senate- by a 2/3 vote.
