

Become a Good Samaritan—Call 911 to Save a Life



The Good Samaritan Law

builds a path for hope and action for anyone witnessing or experiencing an opioid overdose. Everyone who is suffering from opioid addiction, family members, communities, schools, law enforcement, and medical professionals is included!

Background

An overdose is a medical emergency. It requires an immediate call to 911. Fearing arrest for illegal drug use causes witnesses not to call 911.



Opioid Overdoses Kill 2 People a Day Hear This!

The Good Samaritan Law provides protection from drug possession arrest when calling 911.

Be a Good Samaritan!

Not calling 911 is # 1 reason overdose victims die!

How It Works

The Good Samaritan Law provides legal action for all to call 911 with hope that a life can be saved!

(Yes- Law enforcement can still secure the scene of an overdose, and arrest for heavy drug trafficking or outstanding warrants)

Narcan (Naloxone) Prescription

The law helps spread the word about Naloxone (Narcan), a medication that can reverse opioid overdoses.

(Yes, The Massachusetts Department of Public Health has provided grants for Narcan distribution)

Now— medical professionals may prescribe Narcan to a family member or acquaintance of someone suffering from opioid addiction. In the event of an overdose, both the person who administers the Narcan and the prescribing professional have legal protection.

Over 19,000 persons were trained to prevent, recognize and respond to an opioid overdose and administer naloxone (Narcan®).

At this time, DPH has documented reversal of over 2000 potentially fatal overdoses.

Law Enforcement Good Samaritan Activities:

National Health Care Reform Affordable Care Act

The 2010 Patient Protection and Affordable Care Act often referred to as ACA is our national health reform law.

ACA supports parity. Parity means insurers must offer addictions and mental health services at same level of benefits they do for general medical services. Many more people are to access services. Until it is real, we move to enforce parity.

ACA provides many opportunities to develop and implement Peer Recovery Support Services. Stay Tuned and Get Involved!

Massachusetts Payment Reform

- Is Supposed to limit healthcare costs without quality loss
- Supports a team approach to health care from prevention to recovery support services
- Establishes A Prevention and Wellness Trust Fund to be administered by the Department of Public Health; funded by health plans for community prevention by a competitive grant process

MOAR participated in a Behavioral Health Task Force Committee, which recommended to the state Legislature, Licensed Alcohol and Drug Counselor I insurance reimbursement, inclusion of peer recovery support services, & increased addiction and mental health curriculum for physicians.

RAH! Peer Recovery Communities Coming Together

MOAR (Massachusetts Organization for Addiction Recovery) and **The Transformation Center** as part of our Recovery Access in Healthcare (RAH!) grant developed this healthcare reform update.

RAH! is funded by the Substance Abuse and Mental Health Services Administration (SAMHSA) through a 2013 Bringing Recovery Supports to Scale Technical Assistance Center Strategy (BRSS-TACS) Grant.

We are bringing our communities together to educate peers on their new health care options, support peers' informed decision making on health plan choices, and educate stakeholders on the benefits of peer-driven recovery support services.

ACA is to Provide All with Good Care So in 2014....

- People with income less than \$43,000 (or \$88,000 for a family of 4) could be eligible for financial help to pay for insurance.
- Pre-existing conditions like addiction or mental health must be insurance covered.
- Annual or lifetime limits on our health plan coverage cannot be capped
- Addiction and Mental Health Services are to be included in a list of "Essential Health Benefits", when we seek insurance through a Health Insurance Exchange.
- Health Homes are to offer us one stop shopping for health care.
- More school-based health centers are to offer mental health and addictions services.
- Long term disability needs are to be met by more community— based care choices.
 (if Massachusetts adopts certain ACA programs).

One Care for Persons with Disabilities on Both MassHealth and Medicare

- Enrollment begins October 1st. Massachusetts One Care (previously referred to as the Duals Initiative) is for people with disabilities between the ages of 21 and 64.
- People with mental health and/or addiction conditions represent more than 67% of those who may participate.
- Coordinated care is to be improved with increased quality, and unnecessary emergency room and hospital use avoided
- Choice in medical provider and health plan is to be offered.

 Services are to include dental, vision, prescriptions, home based personal care services, and expanded addiction and mental health services (including peer services). Questions:

Next— Massachusetts Medical Marijuana Law

- Massachusetts is now 1 of 20 states with a medical marijuana law, managed by The Department of Public Health.
- Patients are permitted a 60-day supply of 10 ounces of marijuana.
- One dispensary (clinic) is allowed in each of our I4 counties, but limits each to 5.
- State rules require dispensaries to be at least 500 feet away from places that serve children, including schools and community centers.
- Boston changed its zoning rules to prohibit dispensaries in residential areas and to require a hearing before the Zoning Board of Appeals.
- MOAR is concerned about youth access, and is very supportive of prevention efforts.
- Research has found that I in II of all marijuana users will become addicted to the drug. If use begins under age of 18, that number rises to one in six people.
